



History.

1860

OUR BEGINNING

Sheikh Noor Ellahi established a general store in Dalhousie, on the border of Kashmir and Punjab catering to the gentry coming in from India.

1915

EARLY EXPANSION

After taking over the family business, Sheikh Fazal Din expanded the business to real estate in which he would rent out bungalows to summer travelers. He also became the guardian of almost all bungalows owned by the Muslim population and cared for them during the winter months.

1940

LAHORE BRANCH OFFICE

After taking over the business from his father, Mumtaz Sheikh Fazal Din established a branch office in Lahore. This led us to become a major supplier for the British Army

1947

PAKISTAN INDEPENDENCE

After Gurdaspur and Dalhousie were given to India, the family was forced to fully relocate to Lahore. The business and all property was lost and a fresh start had to be made. The name of the business was changed to Fazal Din & Sons.

1953

LCPW

Lahore Chemical and Pharmaceutical works was established on the Canal Bank in Lahore and started production in the same year. It focused on tinctures selling to institutions and the army.

1963

STATE OF THE ART FACTORY

A brand new factory is established on Ferozpur Road with the help of Foreign Consultants. By 1965 the total production of Lahore Chemical & Pharmaceutical Works was shifted to this location. Over the years, it entered into numerous technical collaborations which are as follows Schering, Vifor, Zyma, Mead Johnson, Bristol Myers, Wampoles, Stiefel, Winthrop, Sterling Drug, Helene Curtis and Elizabeth Arden.

1979

MEDIQUIPS

Mediquips was born as a result of collaboration between Toshiba and The Fazal Din's Group. This company is now one of the largest suppliers of electro medical equipment in Pakistan and is known for its outstanding customer service and support.

1982

MEDIPHARM

Medipharm Ltd. was born a result of a joint venture between the Fazal Din's Group and Bayer Schering AG, Berlin.

LCPW EXPANSION

Another state of the art plant is established in Lahore adjacent to the Medipharm plant to manufacturer infusions exclusively. This was the largest plant of its kind in Pakistan.

Fazal Din & Sons Suture and Staple Company was established and was the sole representative of the United States Surgical Corporation (USSC) dealing in surgical sutures and surgical staples
